Serious fight fans have by now seen the video snippet making the rounds, which shows the strength and conditioning coach/cutman for Marcos Maidana, the notorious Alex Ariza, putting on Saturday night what looks like a napkin up to Maidana's mouth in between round 11 and 12 of his fight against Adrien Broner. The meme's purveyors have been implying, or outright alleging, that Ariza is slipping something into Maidana's mouth, and the spotlight is on the former Manny Pacquiao team-member.
