

## Mayweather Jail Term Postponed; Boxer Must Report June 1...WOODS

Floyd Mayweather was supposed to report to jail today, but received a postponement from the court in Las Vegas and instead will report June 1.

David Mayo of MLive.com reported that Mayweather's attorneys argued that the boxer has a fight due May 5, and a Jan. 6 report date would impinge upon the early summer bout. Mayweather was sentenced to six months for battery, and the justice of the peace suspended three months of the term. He'd have been released in early April, giving him only a few weeks to get ready for a May 5 contest, against a foe to be named. The justice said she didn't know of the early summer set-up when she sentenced him before Christmas.
